### 4. First-aid measures

<b>Inhalation</b>	Move to fresh air. Call a physician if symptoms develop or persist. Harmful if inhaled.
<b>Skin contact</b>	Remove contaminated clothing immediately and wash skin with soap and water. In case of eczema or other skin disorders: Seek medical attention and take along these instructions.
<b>Eye contact</b>	Rinse with water for at least 15 minutes. Remove contact lenses if present and easy to do so. Immediately call a physician or transport to hospital.

<b>General information</b>	Ensure that medical personnel are aware of the material(s) involved, and take precautions to protect themselves. Wash contaminated clothing before reuse. Use with extreme caution. Note to physician: If the product is ingested, probable mucosal damage may contraindicate the use of gastric lavage. Treat the affected person appropriately.

### 5. Fire-fighting measures

<b>Suitable extinguishing media</b>	Water fog. Foam. Dry chemical powder. Carbon dioxide (CO <sub>2</sub> ).
<b>Unsuitable extinguishing media</b>	Do not use water jet as an extinguisher, as this will spread the fire.
<b>Specific hazards arising from the chemical</b>	During fire, gases hazardous to health may be formed (hydrogen chloride gas).

### 6. Accidental release measures

<b>Methods and materials for containment and cleaning up</b>	This product is miscible in water.  Large spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Prevent entry into waterways, sewer, basements or

confined areas. Following product recovery, flush area with water.

Small spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills to original container for re-use. For waste disposal, see section 13 of the SDS.

**Environmental precautions** Avoid discharge into areas not consistent with package labeling.

## 7. Handling and storage

**Precautions for safe handling** Avoid breathing mist or vapor. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Provide adequate ventilation. Wear appropriate personal protective equipment. Observe good industrial hygiene practices.
